Upper roof:

- 1. 115mil Fleece back TPO membrane adhered with urethane insulation.
- 2. Follow manufactures specs -basses of design Johns Manville.
- 3. This is over two old roof installations.
- 4. Remove 4 old roof curbs approx. 36" x 36" and patch openings and insulation and roof materials as required.

Lower roofs:

- 1. Tear off old roofing systems
- 2. New roof system to have 1/8" taper with a 1 ½" start mechanically attached ISO with fully adhered 60mil TPO.
- 3. Follow manufactures specs. Basses of design Johns Manville
- 4. Remove old screen wall metal panels and replace with new 2' higher then old. Color to match gravel stop.

Units cost

- 1. Provide unit cost to replace tectum and corrugated deck
- 2. Provide unit cost to replace 2Xs as needed
