SECTION 09642 - WOOD GYMNASIUM FLOORING

PART 1 - SCOPE OF WORK

- 1.01 This section includes the following:
 - A. Sand, refinish and re-stripe the Gym Floor.

PART 2 - SUBMITTALS

- 2.01 Submit (3) three sets of manufacturer's descriptive literature and MSDS for all material to be used on this project. This must be included in bid packet.
- 2.02 Contractor must be a firm experienced in sports flooring field and have been in business a minimum of 10 years.
- 2.03 Contractor shall be MFMA Accredited.
- 2.04 Submit (10) ten references for jobs of similar scope and magnitude that your company has performed in the last (3) three years.

PART 3 - MATERIALS

- 3.01 The floor seal and finish shall be MFMA approved oil-modified products.
- 3.02 The striping paint shall be recommended by the finish manufacturer.
- 3.03 Any and all other materials needed shall be compatible with and approved by the manufacturer of the gym floor finish materials, and with the Maple Flooring Manufacturers Association (MFMA).
- 3.04 Provide the owner with maintenance instructions, including material recommendations for this floor finish and subsequent recoatings.

PART 4 – REFINISHING

- 4.01 This contractor or owner shall provide facilities for receiving and unloading his deliveries at the site.
- 4.02 Normal ventilation will be provided while this work is in progress by the owner. The contractor will relate any special requirements.
- 4.03 The entire gym floor shall be machine and hand sanded as necessary to remove all existing gamelines and finishes, and to a smooth surface. Contractor must use a minimum of 3 (40, 60, & 100 grit) types of sand paper, and the floor must be sanded until it is uniformly dull. Vacuum and tack with a clean cloth immediately before applying finish.
- 4.04 Refinish the gym floor as follows:
 - A. Apply one coat of seal and allow to dry.
 - B. Machine buff, vacuum, and tack.
 - C. Apply second coat of seal and buff the floor.
 - D. Apply the gamelines and graphics and allow to dry.
 - E. Abrade paint and buff.
 - F. Apply one coat of floor finish and allow to dry.
 - G. Buff with steel wool and tack rag.
 - H. Apply a second coat of floor finish and allow to dry.
- 4.05 Final dusting and cleanup of areas will be by the owner.
- 4.06 The gamelines and graphics shall be applied to match the owner-approved drawings.
- 4.07 The courts shall meet the requirements of the appropriate athletic associations and as directed by the owner.
- 4.08 Line colors shall be selected from the manufacturer's standard colors as determined by the owner and the contractor.
- 4.09 All work is to be in accordance with the Maple Flooring Manufacturer's Association (MFMA) guidelines and recommendations.

PART 5 - CLEAN UP

- 5.01 Do not cover wood flooring after finishing until finish reaches full cure.
- 5.02 All trash, excess materials, etc., shall be cleaned up, removed from the site, and disposed of properly and legally.

PART 6 – WARRANTY

6.01 Contractor must provide workmanship warranty for a period of one (1) year after date of substantial completion.
